PERSONAL INFORMATION PROTECTION POLICY

2. FORMS AND COLLECTION METHODS

Your personal information is collected through the following methods:

- Job application form
- Contact form

We use the collected information for the following purposes:

- To gather data on your use of our website.
- To send you samples
- To provide you with relevant information about our activities
- To get in touch with you
- To optimize our website management
- For recruitment purposes
- To enable you to communicate with us

We only use personal information for the purposes for which it was collected.

3. LOG FILES AND COOKIES

We collect certain information through log files and cookies. These files allow us to process statistics and traffic information, facilitate navigation, and improve the service for your convenience.

a. Description of cookies used by the site

These mainly include the following information:

- Browser
- Operating system
- Visited pages and queries
- Date and duration of connection

The use of such files allows us to achieve the following objectives:

- Statistical studies

Additionally, the site integrates social media buttons allowing you to share your activity on the site. Cookies from these social networks may therefore be stored on your computer when you use these features.

b. Opting out of site cookies

You can opt out of the storage of these cookies by configuring your browsing software.

If you decide to disable cookies, you can continue browsing the site. However, any dysfunction of the site caused by this manipulation cannot be considered our responsibility.

4. SHARING OF PERSONAL INFORMATION

The personal information collected by the site is not transmitted to any third parties and is only processed by us.

5. DURATION OF PERSONAL INFORMATION STORAGE

Tilton will keep all personal information collected in its computer systems in Canada and under the best security conditions for a reasonable period or if we have a legal obligation to do so. Once the retention period has expired, personal information will be securely destroyed.

6. PERSONAL INFORMATION PROCESSING MANAGER

a. Personal Information Processing Manager

7. YOUR RIGHTS

You have the right to object to the processing of your personal information. You also have the right to request that your personal information no longer be included, for example, in a mailing list. You can access, update, modify, or request the deletion of information about you.

To make a request regarding your above rights, you must follow the following procedure:

We decline any responsibility regarding the disclosure of such information about you unless due to negligence on our part.

We are committed to maintaining a high level of confidentiality by integrating the latest technological innovations to ensure the confidentiality of your personal information.

Our website is not designed or intended for children under 14 years of age. Therefore, please do not provide us with personal information about children under 14 years of age without first obtaining parental or guardian consent.
